EWC Conference in Ireland

Dublin, 13 - 15 June 2022

Until now, the EWC Academy has held six EWC conferences in London. With Brexit we are now moving them to Dublin, as many UK and US companies have done with their EWCs. However, Irish law does not meet the standards



of the EU Directive (see report www.ewc.news.com/en012021.htm#1). The meeting will be interpreted simultaneously. The evening program includes a visit to the Guinness Storehouse, the historic brewery with a panoramic view of the city.

Legal basis for attending the conference:

EWC members from EU Member States as well as from UK, Norway, Iceland and Lichtenstein can request central management for time-off work and to cover conference expenses on the basis of article 10 (4) of the Directive 2009/38/EC. The EWC agreement or SE participation agreement usually makes explicit provisions for a right to training. In general these also apply to members from Switzerland and other non-EU countries. EWC members from companies which are subject to German legislation, are able to participate under the provisions of Article 38 (1) of the German EWC Act. Members of SE works councils governed by German law may participate in accordance with Article 37 (6) of the Works Constitution Act.

The role of the EWC under extreme pressure for change

TUI is the world's largest tourism group with travel agencies, hotels, airlines and cruise ships and 50,000 employees worldwide. During the Corona crisis, operations had to be almost completely shut down and 8,000 jobs cut. How was the TUI Europe Forum, which is the name of the EWC, able to secure its information and consultation rights in this situation? The agile and participative approach developed in recent years to cope with ever faster decision-making processes came under great pressure. Replacing face-to-face meetings with videoconferences increased the workload, but also offered new opportunities.

 Court proceedings under UK legislation and EWC work under Irish jurisdiction

In October 2020, a court in London fined Verizon £40,000 (about €44,000). This amounts to three times the maximum fine under German EWC law. The judges considered the 14-day deadline given to the EWC to render its opinion to be mere "lip service" and not a willingness to engage in serious consultations (see: www.ewc-news.com/en032020.htm#7.3).

Furthermore central management had declined to pay the EWC's lawyer. As early as October 2019, therefore, the court had already come to a historic decision for British standards, that the EWC could hire a lawyer of its own choice. These costs are part of the "means required" of the EWC to fulfil its tasks (see: www.ewc-news.com/en042019.htm#2).

Confidentiality rules in the EWC

A study published in May 2020 highlighted the problems whereby excessive rules on confidentiality hinder the flow of information within the EWC. Central management may classify information as "confidential" and prohibit the EWC from sharing it with others (e.g. local works councils). However, central management may also refuse to disclose information to the EWC on grounds that stock exchange rules prohibit it or that it could result in damage to the company (secrecy). Central Arbitration Committee, London, March 2021: central management must disclose business figures for individual countries (Adecco case), EWC is authorized to inform the workforce in critical terms on outsourcing (Alliance Healthcare case)
